New Look for Delta Beta Chapter House



In May 2009, as soon as the last collegian packed her car and headed home, major work commenced on the exterior of 900 NE 'B' Street, the home of Alpha Gamma Delta.

A crew of roofers descended upon the house to replace a damaged roof, make soffit and eave repairs and add new gutters.

Masons were called in to repair and re-point the brick and reattach the chimney and fire escapes to the exterior walls.

At the same time, another crew began replacing 130

windows with new double-pane insulated units to help the Delta Beta chapter house become more energy efficient.

This efficiency was enhanced by also installing two new "munchkin" natural gas furnaces which replaced the old basement boiler. Guaranteed to prove "our old house" is not as cold as Kansas anymore!

By July, gallons of khaki (could it be buff?) paint were applied to give the chapter a new updated appearance. The French exterior lanterns were repaired and painted. And, to add a new fresh appearance, black awnings were installed above the French

doors and windows in the front of the house.

Final touches included new red front door paint and the "tombstone" Greek letters were painted to accent the AGD.

Lastly, new Alpha Gamma Delta lettering was placed above the entry door to help identify our chapter on WSU's Greek Row.

It took organization, a strict schedule and dedicated crews but the end results of the remodel have turned out beautifully! Please stop by. You will be as excited as the women currently residing on 'B' Street!
